

## Rules To Enter Hinkley Lighting \$5,000 Home Lighting Makeover Sweepstakes

Winner will be selected in a random drawing to be held on or about December 15, 2009 at Hinkley Lighting in Cleveland by an independent judge whose decisions are final and binding in all respects regarding this promotion. Winner will be notified by telephone, email and/or certified mail on or about December 21, 2009.
